They are proposing to expand their affected area to layback the highwall on the SW side, incorporate an area on the NE side where we cited them for pushing topsoil outside the permit boundary, and it looks like adding a pit on the south end of their property (I'm still reviewing the application, but that's what is showing up on Exhibit F-1, reclamation map). It's in our online documents if you want to check it out. Just put in the permit number (without dashes - M1977247), click on the "Doc Date" column header twice and that will sort it in chronological order, newest documents first.
