Dear Mr. Czapla

Climax Metallurgy would like to run a short test on two new frothing reagents that would be used in the flotation process. The reagents are Quadrafroth P75 and Quadrafroth P100 from Quadra Chemicals Inc. (see attached SDS's). The proposed dosing rate for these reagents would be 0.05lb/ton of ore. The test will occur over the next month. Both reagents will be stored in a 275 gallon tote and placed on a secondary containment pallet with in the mill building to provide tertiary containment. In the event we see any issues with our process from the reagent testing, we will discontinue the test and dispose of the remaining chemical in accordance with waste regulations. We will update the EPP if we decide to make this change permanent.

Please let me know if you have any concerns. We would like to begin the test as soon as possible.

Appropriate engineering controls
