Re: Sessions Pit, Permit M-2008-030, Technical Revision Approval - Revision TR01 and Notice of Required Surety Increase

Mr/Ms. Sessions:

On May 21, 2020 the Division of Reclamation, Mining and Safety approved the Technical Revision application submitted to the Division on April 21, 2020, addressing the following:

Modify mining plan to allow for benched mining. Maximum benched horizontal distance (working face) of 200 feet, and a maximum pit depth of 50 feet below original grade. Bench height/face must be no greater than 16 feet, and bench width(s) must be no less than 3X maximum bench height.

The terms of the Technical Revision TR01 approved by the Division are hereby incorporated into Permit M2008-030. All other conditions and requirements of Permit M2008-030 remain in full force and effect.

In addition, the revised liability amount for this site exceeds the performance bond currently held (see below). As previously discussed, the required increase in bond is a result of the new benched configuration approved in TR01, in addition to the periodic, routine recalculation of the reclamation bond that the Division is required to perform. A summary of the bond calculation has been attached to this letter for your reference.

The revision will not be final until the increased bond is approved by the Division, and the increased reclamation bond is due within 60 days of the date on this letter (No later than Monday July 20, 2020). Failure to submit the required additional bond within 60 days may result in enforcement action.

Bond Held:	\$17,000.00
