Since we did not want to risk our reclamation efforts we elected to hydro-seed the area which encompasses the TR before we lost our planting season.

Due to the shear file size, I am sending this information to you in two separate emails. This being 1 of 2, has photos of the graded area along with a packing slip showing proof of purchase for seed mix. Email 2 of 2 will show remaining photos of reclaimed area being hydro-seeded.
