Hi Jacob.

As you recall in May 2020 the water treatment plant at the Schwartzwalder Mine failed a WET test for the fathead minnow test species. In response to this result, and in accordance with our discharge permit (CO-0001244), we conducted accelerated WET testing in June 2020. This email serves as written notification of the passed accelerated WET testing. The sample results for the initial failed WET test, and the two consecutive passed WET tests are attached. No pattern of toxicity has been identified, therefore we will resume routine testing.
