REVISED SOURCE OF LEGAL RIGHT TO ENTER

This document entirely supersedes and replaces that certain Source of Legal Right to Enter signed by Ronald K. Stewart for the County of Boulder, a body corporate and politic ("Boulder County") on January 14, 2014 and that certain Source of Legal Right to Enter signed by the undersigned on July 8, 2020.

As property owner of that portion of the property included within Division of Reclamation, Mining and Safety Permit No. M-1977-141 – Lyons Quarry, which is a portion of the property described in that certain Special Warranty Deed from Jethro Investment Trust, et al. to Boulder County dated March 30, 2011, and recorded on May 31, 2011, at Reception Number 03141208 in the real estate records of Boulder County, Colorado, made a part hereof by reference, the undersigned hereby grants Aggregate Industries-WCR, Inc. ("Aggregate"), the legal right to enter said property for the sole purpose of reclaiming said property in accordance with the requirements of the permit.

Boulder County does not grant Aggregate a legal right to enter the property for any other purpose, and specifically prohibits Aggregate from mining or removing material from the property except as is reasonably necessary to reclaim the property in accordance with the requirements of its permit.

This legal right to enter automatically expires on February 28, 2022, unless extended by Boulder County in writing.
