
LOCATION INSET



Cotton Creek Pit

A tract of land localed in the Northwest Duarter (NWX) of Section 27. Township 45 North, Range 10 East, New Mexico Principol Meridian, Saguache County, Colorado, more particularly described as follows:

Beginning at a point from which the Northwest Corner of soid Section 27 bears N 75'00'13' W a distance of 1804.99 feet; thence N 90'00'00' E a distance of 761.20 feet; thence S 00'00'00' E a distance of 741.19 feet; thence N 50'00'00' W a distance of 379.08 feet; thence N 50'00'00' W a distance of 480.00 feet; thence N 50'00'00' W a distance of 680.00 feet; thence N 50'00'00' W a distance of 680.00 feet; thence N 50'00'00' W a distance of 680.00 feet; thence N 50'00'00' W a distance of 680.00 feet; thence N 50'00'00' W a distance of 150.00 feet to the True Point of Beginning, containing 9.994 acres, more or less.

TOGETHER WITH on eosement 50 feet in width for ingress ond egress to the obove porcet, the centerline of said eosement is described as follows: Beginning at a point on the south right-of-way line of County Road CC from which the northwest corner of Section 27 bears N 8854187 W a distance of 215597 feet, thence \$ 000000 E a distance of 42581 feet to the north line of the obove described parcel. It is intended that the sides of this eosement be lengthened or shortened to intersect the parcel and the county road R-O-W
