Dear Mr. Marshall

The BLM has no objection to the Colorado Division of Reclamation, Mining and Safety (CDRMS) granting Shell Frontier Oil & Gas Inc. the surety release of P-2003-015 and acreage reductions for P-2003-018, P-2004-011, P-2005-001, and P-2006-037. These CDRMS Prospecting Permits are located on BLM administered lands and were authorized by the BLM under BLM Right of Ways (ROW). The following table contains the ROWs that correspond with the CDRMS Prospecting Permits and the areas that have met the ROW site rehabilitation requirements.
