8. The total disturbance at the mine is 38.35 acres ±. This disturbance came from when the mine was operated under another permit#M-1977-560. There are 2 areas considered pre-Law disturbance area (yellow) that need no reclamation unless re-disturbed, and an old Industrial area (brown) on the west side that just needs grading if mining ends. No new mining was done this year, we continued to removed material from stockpiles in the old plant site area. Mining continued on areas previously disturbed by. The following list outlines the various areas of disturbance at the mine in 2020.

- 9. We removed material stockpiles that were in place when the permit was issued. If gravel extraction resumes it will be on the divider between the two lakes on the southwest side of the mine. We expect to start removing the material between the 2 lakes this year if the demand for material increases. This would open 0.95 acres or more.
- 10. No reclamation is required at this time.
- 13. The lake perimeters slopes on the east, north and west sides were graded when we took over the permit. The old plant site area has no topsoil nor was any reserved prior to permitting.
- 14. Tamarisk control was done from May 1-15th 2020 on the old Plant Site this year using mechanical methods to dig or cut the plants. Spraying was also done in some areas not accessible by equipment using Rifle @ 1 Pint/ac and Madog @ 1quart/ac. A copy of an e-mail to Mr. Daniel Cunningham documenting the weed control efforts is attached for the file.
- 15. Only the lake shores created after mining ends are the only areas that need topsoil. The old Plant Site area does not need resoiling since this area was used as an industrial area since the 1960's and topsoil is not available for resoiling the area.
- 19. Current Bond Amount \$16,548.00. The bond evaluated by the Division on 1/24/2020 and determined to be sufficient.
