OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety (Division) normal monitoring program. The Whirlwind Mine is a 112d-1 underground Designated Mining Operation that includes a total of 31.9 permitted acres with a maximum disturbance of 22.6 acres. To date approximate 12 acres have been affected. The site located seven mile southeast of Gateway, Colorado. Amy Yeldell of the Division conducted the inspection. No representatives from the BLM or Energy Fuels Resources (USA) Inc. were present for the inspection but notifications were made prior to the inspection.

The site was inactive at the time of the inspection and remains in temporary cessation. This is the second continuous period of temporary cessation (TC-2). TC-2 began on September 19, 2017 and will end on September 19, 2022. In general site conditions appear to be unchanged as compared to the previous inspection.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The fenced off buildings and water treatment areas were locked. Without being able to access those areas they appeared to be in compliance. Ground water monitoring data remains up to date. The water treatment facility remain secured and dry.

Staff was able to inspect the portal area. The portal also remains locked and secured. All of the flat parking and pad areas have been mowed. The site was free of weeds. No erosion was observed and the site appears stable.

The Division currently holds a financial warranty amount of \$375,078 for this site.

No problems or violations were noted during this inspection.
