Washington Co. R & B Dist. 3; 11920 CR CC, Anton Co. 80801 has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for Extraction of Construction Materials. The proposed mine is known as the Nelson Pit, and is located at or near Section 18, Township 5 South, Range 55 West, 6th Prime Meridian. The proposed date of commencement is as soon as approved, with an estimated approval date of November 10th, 2020, and the proposed date of completion is November 1st, 2050. The proposed future use of the land is Rangeland. Additional information and tentative decision date may be obtained from the Division of Reclamation, Mining, and Safety, 1313 Sherman Street, Room 215, Denver, Colorado 80203, (303) 866-3567, or at the Washington County Clerk and Recorder's office, old Washington County Courthouse, 150 Ash Avenue, Akron, Colorado 80720, or the above-named applicant.

Comments must be in writing and must be received by the Division of Reclamation, Mining, and Safety by 4:00 p.m. on October 20th, 2020.

These subjects, and similar ones, are typically addressed by your local governments, rather than the Division of Reclamation, Mining, and Safety or the Mined Land Reclamation Board.
