Kevin,

I will use the email you sent Amy on September 22nd as the Notice of Completion of Prospecting, in accordance with Rule 5.3.4, for the Golddigger I (NOI File Number P-2009-007). The next step is to allow adequate vegetation to establish then submit a Reclamation Report and a request for reclamation responsibility release.

In accordance with Rule 4.16.1(2), the Reclamation Report needs to contain:

- (a) the name of the operation, the name of the prospector, file number, mailing address and phone number of the contact person;
- (b) a signed statement by the Prospector that all reclamation requirements of the prospecting notice have been satisfied;
- (c) a narrative describing site grading, topsoil replacement, successful revegetation and other stabilization activities, as appropriate;
- (d) suitable photographs of the reclaimed area; and (e) a map of sufficient detail to determine the location of the prospecting activity.

If all goes well and the grass comes back pretty good, we may be able to entertain a release request at the end of next summer.

As a reminder, the Annual Report, Map, and Fee will still need to be submitted electronically through the ePermitting account each year on March 8th until the site is released. The current email address assigned to the ePermitting account for this site and will receive an email 30 days prior to the annual report date is [platinumman20@yahoo.com](mailto:platinumman20@yahoo.com) which I believe is still Chris Garrison's email as he is the official Prospector and NOI holder.
