Leigh,

I disagree. MR-453 provides a plan for the South Prong Stream restoration that is consistent with MCC's existing approved reclamation plan for subsidence mitigation and with the revegetation of riparian areas. As I reconsidered this submittal, I did not believe that this plan (not an engineered design) would "...cause a significant alteration in the operator's reclamation plan", nor was it a "design change for regulated structures or facilities" as is defined in the regulations for a technical revision. Any chance that you can reconsider and accept the Minor Revision application?
