I am writing about the above-mentioned application by Peak Materials to establish a gravel mining operation at the site designated as Peak Ranch Resource.

I would be amenable to the proposed expansion if the impact of the additional trucking as a result of this action is mitigated with. Hard rock mining and production facilities are important to the health of a County; and with limited options in the mountains, it only makes sense to improve an existing facility over development of a new facility. That said, additional trucking will exponentially increase as a result of this action. I would support the expansion if the Board found a way to minimize this impact. Sound barriers along the highway 9 corridor, limited work hours of trucking / allowance of minimal nighttime trucking days, require engine exhaust mufflers, no Jake brake zones inside city limits & enforcement to Peak Materials of the leased trucking operators, could be some reasonable options to evaluate.
