A Formal Public Hearing will be held during the November 18, 2020 Mined Land Reclamation Board Meeting for presentation of Climax Molybdenum Company's proposal to use Water Rights and Real Property deeds of trust as a financial warranty, and approval for the Division to move forward with further due diligence and retention of an independent appraiser for the review of the proposal.
