**Public Notice** Mountain Coal Company, LLC (MCC), 5174 Highway 133, Somer-set, CO 81434, (970) 929-5015, has filed a complete application for Tech-nical Particles No. nical Revision No. TR-148 to MCC's Mining and Reclamation Permit No. C-1980-007 with the Colorado Mined Land Reclamation Board (Board), under the provisions of the Colorado Surface Coal Mining Reclamation Act of 1979. The permit was originally issued by the Board in July 1981. issued by the Board in July 1981, and subsequently renewed in August 1986, January 1993 (effective Au-gust 1991), July 1996, July 2001, April 2007 (effective July 2006), November 2011 (effective July 2011), and September 2020 (effec-tion July 2016). The Wast Elk Mina 2011), and september 2020 (effec-tive July 2016). The West Elk Mine five-year permit area contains lands in Sections 9-11, 13-36, T13S, R90W, 6th PM; Sections 23-26, T13S, R91W, 6th PM; and Sections 1-5, 8-12, 14-16, and 21-23, T14S, R90W, 6th PM in Delta and Gunni-son Counties.
