Rudy is correct. The maps included only showed the areas requesting to be released. They do not show the entire permit area, the revised/proposed permit boundary lines or any other changes that have occurred to the site since the original submission more than 15 years ago. All maps need to comply with Rule 6.2.1(2), and more specifically revised mining and reclamation map requirements come from Rules 6.4.3 and 6.4.6.
