NOTICE OF PROPOSED DECISION

The Colorado Division of Reclamation, Mining and Safety proposes to approve Technical Revision Application No. 95 (TR-95) for the Foidel Creek Mine (Permit No. C-1982-056), submitted by Twentymile Coal, LLC. TR-95 proposes to install a pipeline for dewatering purposes from the Western mine district. The pipeline will run from the existing 16LT Utility borehole to the existing 18LT shaft pad location, where it will tie into the 18LT dewatering line that runs to the Fish Creek treatment location. The pipeline will be approximately 5,700 feet and consist of single walled 12 inch HDPE pipe. In order to provide power to the 16LT utility borehole, a powerline will be placed in the same corridor as the pipeline.

The Foidel Creek Mine is a/an underground coal mine located in Routt County, approximately 2.5 miles SW of Steamboat Springs, Colorado. Coal interest is federal, state and private, and the surface affected is federal, state and private land. The permit area encompasses approximately 22,647.06 acres.

This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 34-33-101, et seq., C.R.S., and the regulations promulgated thereunder.

Persons with an interest that may be adversely affected by the proposed decision may request a formal hearing before the Mined Land Reclamation Board on the proposed decision. Such request must be made within ten (10) days of the initial publication of this notice, must be in writing, and must state with reasonable specificity the reasons for the request and the objections to the proposed decision.
