Amy:

We are in receipt of your third adequacy letter. As noted earlier, full size maps were delivered to Denver on Tuesday. It is much easier to see detail on the full sized maps.

I have relayed your letter to the client, but he has not yet seen it.

Frankly, there is no way to make further modifications to the six plat maps and possibly develop new unified maps by tomorrow for delivery Monday. I am certain that even a first meeting with the surveyor could not be arranged that quickly, much less multiple map modifications made.

I would request a delay of the decision date; if that cannot be done I would like to place this matter before the Board regarding an extension of the decision date.

24-hour compliance with your list of requests is simply not physically possible, and I doubt that I could even develop intelligent comments by tomorrow.
