



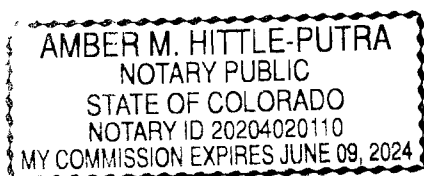

A REGULAR (112) CONSTRUCTION MATERIALS RECLAMATION PERMIT

The following public notice is for reconsideration of a Regular (112) Construction Materials Permit which was previously approved by the Division of Reclamation, Mining and Safety on November 6, 2019.

The Ellicott Sand and Gravel, LLC, 235 Franceville Coal Mine Road Colorado Springs, CO 80929, has filed a request for reconsideration of an application for a Construction Materials Regular 112 Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions with the Colorado Mined Land Reclamation Act for extraction of Construction materials. The proposed mine is known as the Schubert Ranch Gravel Resource, (Permit # M-2018-063 and is located in or near the SW¼ of Section 20, E½ of Section 29 and parts of the S½ of Section 32, T-14-S, R-62-W of the 6th P.M., El Paso County, Colorado.

The date of commencement will be June 2021 the proposed date of completion is December 2050. The proposed future use of the land is rangeland.
