PUBLIC NOTICE

Elk Ridge Mining and Reclamation, LLC, P.O. Box 628; Nucla, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for Technical Revision No. 101 (TR-101) to the New Horizon Mine Permit No. C-1981-008. TR-101 proposes to relinquish monitoring of two locations of three sets of ground water monitoring wells, one ground water monitoring well completed in a pre-law mining area not associated with New Horizon Mine, and one surface water monitoring location.

The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nucla, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North, Range 15 West; Section 31, Township 47 North, Range 15 West; Section 1 Township 46 North, Range 16 West; Section 36 Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado. The above mentioned tracts of land are shown on USGS 7.5 minute Nucla Quadrangle map.
