The Division of Reclamation, Mining and Safety received a complaint of a possible illegal mining operation from Weld County on a parcel of land owned by New Vision Investments, LLC located north of WCR 2 and west of WCR 42. I was given your contact information by Weld County. The complaint states 60,000 cubic yards of material was being removed from the site to construct a drainage pond.

The Division will require you to complete an "Is It Mining" questionnaire to determine if the excavation work requires a permit from the Division. A copy of the questionnaire is attached.
