Climax Metallurgy would like to run a short test on a reagent that would be used in the flotation process. The reagent is Quadrafroth 612 from Quadra Chemicals Inc. (see attached SDS). The proposed dosing rate for the product will be 15g/ton of ore. The test will occur over the next month. The reagent will be stored in a 250ml container and placed in secondary containment within the Climax metallurgical lab. In the event we see any issues with our process from the reagent testing, we will discontinue the test and dispose of the remaining chemical in accordance with waste regulations. We will update the EPP if we decide to make this change permanent.

Please let me know if you have any concerns. We would like to begin the test as soon as possible.
