Re: RFL Rockshop; Permit No. M-2021-017; Need for State Mine Reclamation Permit

Dear Mr. Pulda,

The Colorado Division of Reclamation, Mining and Safety (Division) has specific Rules and Regulations for Hard Rock, Metal, and Designated Mining Operations, adopted by the Colorado Mined Land Reclamation Board in January 2015. These rules are in accordance with the Colorado Mined Land Reclamation Act (Title 34 Article 32). It has come to the attention of the Division that you may be conducting mineral operations at your claim that requires a mine reclamation permit. The Division has assigned permit ID number M-2021-017 to your claim. Please reference this Permit ID number on any correspondence you submit to the Division.

As defined in the Act (34-32-103(8)), "<u>mining operation</u>" means the development or extraction of a mineral from its natural occurrences on affected land. These activities would need an approved mine reclamation permit with the Division.

As defined in the Act (34-32-110), any person desiring to conduct limited mining operations may apply for the expedited processing of a mine reclamation permit under two categories: 110(1) – for operations on less than five acres; or 110(2) – for operations on less than ten acres. Both categories limit material extractions to less than 70,000 tons of mineral or overburden or combination of the two per calendar year.

An approved reclamation permit is required prior to conducting any mineral mining activities on your claim. If you have any questions regarding whether your activities require a reclamation permit, please contact me at (720) 774-0040 or <u>brock.bowles@state.co.us</u>.
