Re: Information Regarding Notice of Intent to Conduct Prospecting Operations Mosquito Creek 1, File No. P-2021-006

Dear James and Rochelle Lundy:

The Colorado Division of Reclamation, Mining and Safety (Division) has specific Rules and Regulations for Hard Rock, Metal, and Designated Mining Operations, adopted by the Colorado Mined Land Reclamation Board. These rules are in accordance with the Colorado Mined Land Reclamation Act (Title 34 Article 32). As defined in the Act (34-32-103(12)), "prospecting" means the act of searching for or investigating a mineral deposit. It has come to the attention of the Division that you may be conducting prospecting operations at your claim that may require a Notice of Intent to Conduct Prospecting Operations (NOI) from the Division. The Division has assigned a File ID number of P-2021-006 to your claim. Please reference this File ID number on any correspondence you submit to the Division.

An approved NOI may be required prior to conducting any mineral prospecting operations on your claim. If you have any questions regarding whether your activities require a NOI, please contact Jason Musick at the Division (303) 866-3567 x 8134.
