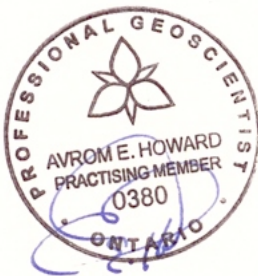

The first quarter, 2021 ("Q1/21") water sampling was conducted by Lewis Perkins, Colorado Milling Company, on April 5, 2021; sampling was delayed due to heavy snow in mid-March.

- **Trace Element & Related Data:** Five monitoring stations were sampled for arsenic, cadmium, manganese, zinc, total dissolved solids ("residue") and sulfate. Analyses were performed by Colorado Analytical Laboratories Inc., based in Denver. Copies of their original laboratory analytical reports are included in this submittal.
- **Other Data:** Water depth, temperature and pH data were gathered by Perkins and Howard, and recorded along with the aforementioned trace element and related data in an Excel spreadsheet, a copy of which is included in this submittal.
