NOTICE OF PROPOSED DECISION

The Colorado Division of Reclamation, Mining and Safety proposes to approve Technical Revision Application No. 24 (TR-24) for the New Horizon North Mine (Permit No. C-2010-089), submitted by Elk Ridge Mining and Reclamation, LLC. TR-24 proposes revisions to the surface and groundwater monitoring program at New Horizon North Mine.

The New Horizon North Mine is a/an surface coal mine located in Montrose County, approximately 2.5 miles NW of Nucla. Coal interest is private, and the surface affected is private land. The permit area encompasses approximately 234.60 acres.

This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 3433101, et seq., C.R.S., and the regulations promulgated thereunder.

Persons with an interest that may be adversely affected by the proposed decision may request a formal hearing before the Mined Land Reclamation Board on the proposed decision. Such request must be made within ten (10) days of the initial publication of this notice, must be in writing, and must state with reasonable specificity the reasons for the request and the objections to the proposed decision.
