OBSERVATIONS

This inspection was conducted by the Colorado Division of Reclamation, Mining and Safety in response to the Succession of Operator approval on February 19, 2021. Bear River S&G, is a 112c permit site that includes a total of 25 permitted acres of which approximately 7 of the 7.5 acre maximum are currently disturbed. It is located approximately 20 miles west of Steamboat Springs, CO and is accessed from Highway 40. Ron Simon representing Bear River Sand and Gravel, LLC, the current operator; Ed Macarthur with Alpine aggregates and Tabetha Lynch of the Division were present on the inspections.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The access road has a locked gate with the identification sign attached. The site was active at the time of inspection and has been operating. The cement batch plant building has been removed, however this building was permitted to remain on site post reclamation and was not previously included in the cost estimate. The site has been cleaned up since the last inspection. Due to the time of year this inspection did not note weeds on site as the previous inspection noted. The operator should work to maintain a weed free site. The operator is encouraged to consult with Routt County's weed specialist at weed@co.routt.co.us.

Stockpiled materials were present onsite. The site appeared stable with no evidence of erosion. The topsoil and overburden piles appeared stable. The western portion of the site has previously been mined and graded. No seeding is noted to have occurred, and due to the time of year of this inspection no species were noted. In the previous inspection it was noted that the reclaimed area had yellow sweet clover, perennial grasses, willow and weeds.

The Division updated the reclamation cost estimate, which was last updated in 2015. A copy of the staff calculations will be sent under separate cover. The current Financial Warranty in place is sufficient to cover the reclamation at the site and a Surety Increase will not be initiated as a result of the approval of SO2.
