## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Bartley Gravel Pit is located approximately three miles southwest of Dove Creek and accessed from L Road. The site is a 112c operation that includes a total of 77.3 permitted acres. Because the site is operated by a county the Division does not hold a financial warranty for this site.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by t-posts and berms that were clearly visible and adequate to delineate the affected area boundary.

Most of the east half of the permit area has been reclaimed. The grading and vegetation blend well with the surrounding area. Small stockpiles of gravel and boulders are located in the pit area. Topsoil is stockpiled on site for reclamation.

The site is well-kempt. No problems or violations were noted during this inspection.
