OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Black Snag pit is located approximately twenty miles northeast of Dove Creek and accessed from Disappointment Road. The site is a 110c operation that includes a total of 9.9 permitted acres. Because the site is operated by a county the Division does not hold a financial warranty for this site.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by t-posts that were clearly visible and adequate to delineate the affected area boundary.

The pit was not active during this visit. Several stockpiles are located in the pit area, including overburden, topsoil and usable material. Pit slopes have mostly been graded to 3H:1V and appear stable. No signs of erosion were noted.

The site is well kempt. No problems or violations were noted during this inspection.
