Mine Land Reclamation Permit M-1977-300 Former Schwartzwalder Mine, Golden, Colorado

Dear Ms. Amy Eschberger:

Colorado Legacy Land, LLC (CLL) recently received an automated email notification stipulating the following submittal dates for quarterly environmental monitoring results:

- First quarter data reported by May 1,
- Second quarter data reported by August 1,
- Third quarter data reported by November 1, and
- Fourth quarter data reported by February 1 (of the following year).

The MLR Permit documents to not specify a specific reporting timeframe, however CLL has consistently provided environmental monitoring data to DRMS the following quarter. CLL is requesting that DRMS revise the automated notification system to reflect the following schedule:

- First quarter data reported in second quarter (by June 30),
- Second quarter data reported in third quarter (by September 30),
- Third guarter data reported in fourth guarter (by December 31), and
- Fourth quarter data reported first quarter (by March 31 of the following year).

The environmental monitoring suite for the Schwartzwalder Mine includes radiological analytes which have an analytical turn around time of 28 business days. A full quarter is needed to accommodate sample turnaround time, reanalysis or resampling (if needed), data management, quality assurance / quality control review, interpretation, documentation, and internal review prior to submission to DRMS. CLL shall continue to prioritize the field sampling schedule so that analytical sample results may be communicated in a thoughtful and timely manner.
