Attached is a request for a Total Surety Release for the above referenced mine, a notarized letter from the landowner asking that permit be released so he can develop the property as he wishes, and a colored map showing the areas discussed in the following text. The mine is located at 7751 I-76 Frontage Rd, Henderson, CO 80640, NW1/4, Sect. 31, Township 2 South, Range 67 West.

AFS is requesting 13.68 acres± be released, thereby releasing the entire permit area. Backfilling, side slope grading, topsoil placement and seeding using the approved seed mix were completed in 2019. This begins the third growing season on the sloped area and the second on the level area outside the landowner dumping area. The grass planted in the past is growing and the landowner's industrial area is still in use.

Reclamation is complete for the mine area in accordance with our approved Reclamation Plan.
