OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Mancos Gravel Pit is located approximately 0.75 miles northeast of Mancos and accessed from CR 42. The site is a 112c operation that includes a total of fifty permitted acres. Because the pit is operated by a county the Division does not hold financial warranty for this site.

Adequate mine identification signage was noted at the entrance to the site.

Mining was not occurring during this inspection. Crushing equipment was not located on site. Several materials stockpiles were located throughout the pit floor. Mining is progressing to the north and west from the original 110c permit area. Topsoil was pushed up into a berm above the mining face. Re-graded slopes at the site appear stable. No erosional issues were noted.

Overall the site is well-kempt. No problems or violations were noted during this inspection.
