OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Cedar Point site is located approximately three miles west of Mancos and accessed from Hwy 160. The site is a 112c operation that includes a total of 126 permitted acres. The Division currently holds a financial warranty amount of \$163,029.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing and landmarks adequate to delineate the affected area boundary.

There was no sign of recent mining activity. Mining had been progressing to the north. Materials stockpiles are still located throughout the pit area. The operator's most recent annual report states they are selling material from existing stockpiles. Only a front end loader was noted on site.

Much of the southern permit area has undergone some reclamation. Slopes have mostly been re-graded or sloughed to 1-2H:1V. Topsoil stockpiles are located throughout the area in near proximity to the slopes for final grading.

No erosional or stability issues were noted.


No noxious weed infestations were noted.


