## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Line Camp Pit is located approximately 7.5 miles east of Dolores and accessed from Hwy 145. The site is a 112c operation that includes a total of 22.6 permitted acres. The Division currently holds a financial warranty amount of \$53,810.67 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by berms and survey stakes that were adequate to delineate the affected area boundary.

Mining was not occurring during this inspection. Conditions were wet and snowy. A scale and scalehouse are located near the site entrance. Various materials stockpiles are located throughout the site. Equipment on site is stored in an orderly manner. Topsoil is stored in stable berms along the west side of the affected area. The ponds are currently full. The pond banks appeared stable.

There are small stands of tamarisk around the ponds. The operator should be proactive in taking measures to eradicate these noxious weeds from the site in order to prevent infestation or offsite migration.

No other problems or violations were noted during this inspection.
