Applicant shall comply with Rule 3.1.5(9) should the Applicant determine that material generated from outside the permitted area is necessary for use on the extended access road.

**Response to History Colorado Comments**

Applicant has reviewed the comments submitted by History Colorado in response to this permit application. Applicant recognizes that the Colorado Cultural Resource Inventory database indicated that no historic properties have been recorded within the subject property, but that there is the possibility that as yet unidentified cultural resources exist within the project area. Should Applicant discover human remains during the project activities, Applicant shall comply with the requirements under C.R.S. 24-80 (part 13).
