OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Buena Vista Pit is located approximately one mile north of Buena Vista and accessed from CR 383. The site is a 112c operation that includes a total of 23.81 permitted acres. The Division currently holds a financial warranty amount of \$50,000.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing and posts that were clearly visible and adequate to delineate the affected area boundary.

The equipment related to a CDOT project observed onsite in April 2017 has been removed and the area cleaned up.

The erosion features that were repaired in 2013 appear in good condition.

This mine site is in final reclamation. Slopes around the pit are mostly graded to 2H:1V, or sloughed, where grading has not occurred yet, to 1H:1V. Several materials stockpiles still remain on site and the operator has stated that material from these piles is occasionally sold while reclamation of the site is ongoing.

No problems or violations were noted during this inspection.
