The additional information requested for the GRE, Inc. (GRE) Notice to conduct exploration activity at Golconda Lode Claim in Hinsdale County, Colorado was received in this office on May 24, 2021. The Notice has been assigned Bureau of Land Management (BLM) case file number COC-80512. Additionally, the Colorado Division of Reclamation, Mining and Safety (DRMS) has assigned the case as Calvert Golconda, File No. P-2021-007 for their records. Please refer to these numbers in future correspondence concerning this operation.

Consistent with the surface management regulations at 43 CFR 3809.311(a), the BLM has reviewed the Notice to determine if it meets the content requirements at 43 CFR 3809.301(b). Based on our review, the following information is required from GRE in order for the Notice to be complete:

1. A reclamation cost estimate is required in order for your Notice to be considered complete (43 CFR 3809.301(b)(4)). Please provide this estimate in accordance with the requirements at 43 CFR 3809.552. A reclamation bond is required in case the operator does not complete the required reclamation (gating the portal to prevent public entry). A reclamation cost estimate includes (but not limited to) costs of material, mobilization, labor and contractor profit as if BLM hires third party contractors to complete the reclamation.

Until a complete Notice is filed with this office, the BLM is unable to determine that your proposed operations will not result in unnecessary or undue degradation as defined under 43 CFR 3809.5. In addition, we are unable to make a determination as to the amount of the required financial guarantee.

Please submit the required information at your earliest convenience. Until we receive this information your Notice cannot be processed and the proposed exploration activity is not to take

place. Conducting the proposed activities before filing an acceptable Notice as required by 43 CFR 3809.21 is a prohibited act under 43 CFR 3809.605(b). Failure to suspend all unauthorized activities will result in enforcement action under 43 CFR 3809.601.
