Hello Mrs. Christensen,

We have reviewed the results of the survey you provided to us and there are some zones that will need to be regraded to a 3H:1V ratio above the waterline. We have informed LRM of this and they have not responded yet. LRM has a due date of July 30, 2021 to submit the results of the below water slopes. We will evaluate those results and determine if any additional earthwork below the waterline is necessary. Please see my May 28, 2021 letter and the May 20, 2021 inspection report for clarification on weed control at the site. It was my understanding based on your June 18, 2021 email that your appeal was premature? Rule 5.5.2 pertains to Exploration operations and is not applicable to this permit. It is my understanding the holding ponds used by LRM have been backfilled and graded, and blend into the surrounding area, I did not witness a "sink hole" on the property. Several other issues from your June 14, 2021 email I have responded to in my previous correspondence and I have nothing further to add.

Attached are picture of the chunks of the slope just falling into the lake also the weeds are out of control. We asked them to mow and they refused. Our attorney contacted their attorney and was told they are not going to do anything, even mow and to do whatever we want to do. Can you please clarify one more time that you are not in charge of enforcing the weeds and the mowing in regards to this mining claim? Please see additional pictures and when the water goes down this fall the shore will be worse and more dangerous than it is now. How long do I need to wait for your response to our appeal? Or is the email you sent me your response?
