**Re: Big R Pit, Permit No. M-1988-052, Notice of Past Due Financial Warranty Increase (SI-02)**

Mr. Mocevic:

On April 20, 2021, the Division of Reclamation, Mining and Safety (Division) issued a Financial Warranty increase (SI-02) to \$51,632.00 for the Big R Pit (see enclosed). This is an increase of \$32,990.00 from the currently held Financial Warranty of \$18,642.00. Pursuant to Rule 4.2.1(2) and C.R.S. 34-32.5-117(4)(c)(II), the additional required Financial Warranty was due within 60 days, by June 19, 2021. As of the date of this letter, the Division has not received the required increase.

Please submit the required additional Financial Warranty by **July 23, 2021**. This can be in the form of an amendment to the current Financial Warranty or submittal of a new Financial Warranty reflecting the increase. If, by the deadline above, the Division has not received the required increase, enforcement actions will be pursued which may include permit revocation, finding the currently held Financial Warranty subject to forfeiture, and the assessment of civil penalties.
