Thank you for you time in this matter.

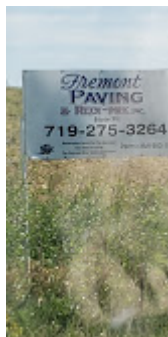

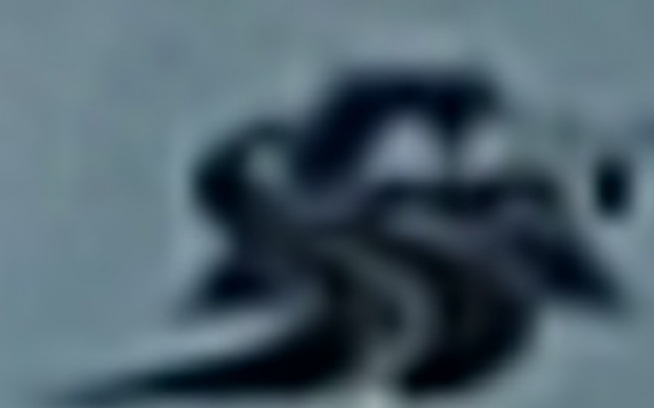
