This firm represents Southway Construction Company, Inc. ("Southway"). This letter is in reference to File No. M-1987-013, MV-2021-001. On January 11, 2021, the Mined Land Reclamation Board signed a Board Order directing Southway to take certain corrective action within 180 days of the Order. The corrective action involves either obtaining a legal right of entry onto the subject property or beginning reclamation on lands (which requires an ability to enter the subject property). Southway respectfully requests a 90-day extension of its deadline under the Order. Southway to date has been unable to gain access to the subject property. However, Southway has been attempting to negotiate with the property owner (Burton Farms, LLLP) to obtain that access or perhaps find some other resolution to this matter. Southway is optimistic that it will be able to complete those negotiations within another 90 days.
