The operations extended beyond the day shift we have been dealing with. The truck traffic went beyond midnight last night! They are using engine breaks and creating extensive noise that is affecting our ability to sleep.

Why are they using WCR7 in the first place since the permit that I read shows that they would use the east access to the mining site?

One of the trucks this week failed to stop before checking for traffic and would have collided with me if I hadn't alerted him with my pickup truck horn. He swerved to avoid contact.
