Please be advised that on May 17, 2021, Young Ranch Resource LLC, whose address and telephone number are 5455 Ulysses Street, Golden, CO 80403; (303) 880-0948, filed an application to conduct a(n) Surface mining and reclamation operation, at or near Section 28, Township 3S, Range 72W, 06th Principle Meridian, in Clear Creek and Gilpin Counties. Please be advised that the permit area may be located in more than one Section, Township, and Range. Affected lands will be reclaimed to support a(n) Rangeland post-mining land use. The application decision date is scheduled for October 14, 2021.

A copy of the application is available for review at the Clear Creek County and Gilpin County Clerk & Recorder's offices and at the office of the Division of Reclamation, Mining and Safety.
