Gravel Property Lease Agreement

This Gravel Property Lease Agreement dated this <u>day of <u>Aucuust</u></u>, 2021, (hereinafter referred to as the "Agreement"), is by and between Ted Franciscotti, ("Lessor"), whose address is <u>155</u> <u>Jun 11</u> <u>KAN</u> and Fremont Paving & Redi Mix, Inc., a Colorado Corporation ("Company"), whose address is 839 Mackenzie, Canon City, CO 81212.

1. In consideration of the sum of Ten Dollars (\$10) paid by the Company to Lessor, the receipt and sufficiency of which is hereby acknowledged by Lessor, and on and subject to the terms and conditions provided in this Lease, Lessor hereby leases, lets and demises to the Company the Materials as defined herein, in, on and under the following described real property situate in Huerfano County, Colorado with a legal description as follows:

the exclusive right to sample, drill, and test for, develop, mine, quarry, extract, process, convey, sell, use, and remove them during the Term of this Lease, along with the right to locate and operate and /or sublease aggregate, asphalt and concrete plants and with associated easements as provided herein.

- 2. <u>Definitions.</u>
 - a. <u>Lease Year</u> shall commence on the date of execution of this Lease, or if not, on the date specified herein by the Parties. The date of commencement shall also be the anniversary date of the Lease.
 - b. <u>Materials</u> shall mean stone, sand and gravel, aggregate and any overburden or other material, other than hydrocarbon minerals such as coal, oil, and gas and associated liquid hydrocarbons, that are weighed and removed from the Property incidental to sand and gravel operations hereunder.
 - c. <u>Net Sales Ton</u> shall mean 2000 pounds of Materials weighed and removed from the Property.
 - d. <u>Plant</u> shall mean a portable and/or fixed facility for processing, storing, washing, sorting, handling loading and shipping of Materials, along with ancillary facilities, including concrete or asphalt batch plants.
 - e. <u>Term</u>. The Term of this lease shall be for a period of Ten (10) years commencing on the date of execution or other date specified by the Parties, which in this case is $3^{\text{PP}}_{\text{AU}(12)}$ 021. The lease shall renew automatically at the end of the Ten (10) year term unless Company
