TR-96 was submitted following the Divisions Surety-Increase No. 3 (SI-3). SI-3 was initiated by the Division after the Mid-Term No.8 Reclamation Cost Estimate update. TR-96 removes approved permitted action that were not conducted. SI-3 was withdrawn by the Division due to the submittal and approval of TR-96.

The Foidel Creek Mine is a/an underground coal mine located in Routt County, approximately 23 miles SW of Steamboat Springs, Colorado.
