OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety (Division) normal monitoring program. The Shults Gravel Pit is a 110c permitted site that includes a total of 9.9 permitted acres. The site is located twelve mile west of Meeker, Colorado and is accessed from County Road 127. Lonnie and Todd Shults represented the operator and accompanied Amy Yeldell of the Division conducted the inspection.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. A signs was attached to the gate was posted at the permit entrance. The permit boundary is delineated by a fence.

The pit was inactive at the time of the time of the inspection. The site is done excavating and processing new material but stockpiles remain on site. No equipment, fuel, buildings, etc. were present on site. Remaining stockpiles are neatly stored according to size class with little to no signs of erosion. Only the perimeter highwall remains. The pit is generally excavated 15 to 4 feet below grade at a sloped to a 2H: 1V. There are two excavation areas bisected by a small ravine. The western site is the main pit with stockpiled material and where processing occurred. The eastern pit is a small bowl approximately 100 by 200 feet. Topsoil is stockpiled on the south side of the main pit above the highwall. Upon final reclamation the pit floor will remain stabilized with gravel for future agricultural use and only the slopes will be revegetated. The entire pit also has a small berm around it. Some nuisance weeds were present, mostly Russian Thistle. Common Mullen was present in a few locations but was not of concern.

The Division currently requires a financial warranty amount of \$9,172.00 for this site. The bond was last recalculated with SR-1 in 2017. In an effort to ensure that the Financial Warranty adequately, reflects the actual current cost of fulfilling the requirements of the approved reclamation plan the Division has updated the reclamation cost estimate and found the current bond sufficient to complete reclamation.

No problems or violations were noted during this inspection.
