OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety (Division) normal monitoring program. The Prather Pit is a 112c permitted site that includes a total of 37.6 permitted acres. The site is located thirteen miles southeast of Meeker, Colorado and is accessed from County Road 8. Clint Chappell and James Haggart represented the operator and accompanied Amy Yeldell of the Division on the inspection. No financial warranty is held for this site as is it operated by Rio Blanco County, per Rule 4.1.2(2).

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. A sign is attached to the gate at the permit entrance. The permit boundary is clearly delineated by t-posts covered with a white PVC sleeve.

This pit is infrequently used. The eastern portion has been reclaimed and has slopes that are regraded to 3H: 1V or less and have well established rangeland grasses. Only screening activities occur on site, no washing or crushing. No processing equipment, structures, fuel, etc. are stored on site.

Overall the site is kept in good working order. Stormwater controls are properly employed with no signs of erosion. Little to no weeds were observed. Native vegetation has volunteered in some areas.

No problems or violations were noted during this inspection.
