Mr. Cazier,

Enclosed are updated Exhibit C, D and F maps. They have been updated based on the Adequacy Response Letter dated 8/17/2021.

Regarding item 7.g., the permit boundary is greater than 200' from Highway 115's right-of-way and thus would not require any structure agreement. Please let us know if additional documentation of this needs to be added to the current maps provided.

Question 9 relates to the mining slopes and highwall. The DRMS is correct, as there was an error in the permit application. The highway is approximately 1000 feet in length with a vertical face.

Question 16 refers to the overburden. Fremont commits to using all available onsite overburden for reclamation of the highwall. It is anticipated that as operations move north and east, more overburden will be encountered. At our present mining area, overburden is limited, but based upon site conditions east of the current mining area, higher quantities of overburden will be encountered and can be used for reclamation.

Fremont intends to renew the current water lease prior to its expiration and will provide a copy of such at that time.

Fremont is still working on the Geotechnical Stability Exhibit and will submit that upon its completion.

Attached are copies of all notices sent to owners of record of lands that are within 200 feet of the boundary of the affected land.
