OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Saguache County Coleman Pit is located approximately 2.5 miles south of Saguache and accessed from CR 47.5. The site is a 112c operation that includes a total of 40 permitted acres. Pursuant to Rule 4.1.2(2) no financial warranty is required for this site.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

The site appears to see little mining activity. Native vegetation and kochia are well established over most of the disturbed area. Several materials stockpiles are located around the pit area. Slopes around the pit have been graded to approximately 3H:1V. No water was observed in the pit. Fuels or mining equipment are not stored on site.

No problems or violations were noted during this inspection.
